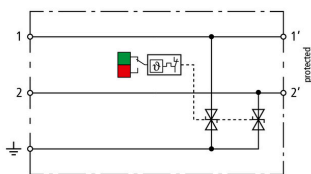

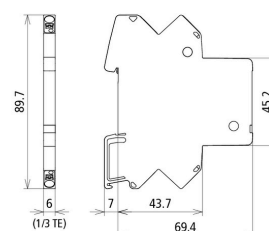
- LifeCheck arrester monitoring and integrated status indication
